



## Expiry of the stowed cover option

Dear Safire Broker,

We trust and hope that you and your loved ones stayed safe during the last 2 months of lockdown.

Although the Coronavirus is by no means under control, and we all need to stay vigilant and maintain the necessary protocols for the foreseeable future, we are cautiously excited at the prospect of business operations slowly returning to normal with the introduction of Level 3 lockdown measures from today.

As you know, we offered our clients the option of selecting stowed cover for vehicles that were not used at all during Alert Levels 4 and 5. With Alert Level 4 now coming to an end, we would like to remind you that all vehicles that were insured under the stowed cover option, will revert to Comprehensive cover with effect from Monday 1 June 2020. Clients will also no longer be able to select stowed cover going forward.

Should the Government decide to reintroduce either Level 4 or 5 lockdown any time in the future, we will at that stage be offering the stowed cover option again.
