Sasria reporting period

Sasria recently announced that the public unrest that took place in July 2021 would be regarded by the public insurer as a catastrophe event. Linked instances of loss that occurred during the period 9 – 19 July 2021 are being regarded as forming part of this catastrophe event.

As with many other insurance policies, a 30 (thirty) day reporting period applies to claims being made against the Sasria policy, meaning that a policyholder intending to claim against the Sasria policy is required to notify Sasria of their claim within 30 (thirty) days from date of the relevant loss (i.e. the date of the event that gave rise to the Sasria-linked loss suffered by the policyholder).

This means that all claims that relate to the abovementioned catastrophe event, should have already been reported to Sasria.

If, for any reason, you have not yet reported all the Sasria claims that relate to this event, we urge you to submit such claims to us without delay, so that we may in turn, as the Sasria Agent, submit the claims to Sasria for their consideration.

Sasria rapporteringsperiode

Sasria het onlangs aangekondig dat die openbare onluste wat in Julie 2021 plaasgevind het, deur hulle as 'n katastrofe gebeurtenis beskou word. Gekoppelde verliese wat gedurende die periode 9 – 19 Julie 2021 plaasgevind het, word as deel van hierdie katastrofe gebeurtenis beskou.

Soos met vele ander versekeringspolisse, is daar 'n 30 (dertig) dae rapporteringsperiode waarbinne eise teen die Sasria polis gemaak moet word. Hiervolgens moet almal wat van voorneme is om teen die Sasria polis 'n eis in te stel, sodanige eis binne 30 (dertig) dae vanaf die datum van verlies, aanmeld.

Dit beteken dat all eise wat met die bogenoemde katastrofe gebeurtenis verband hou, dus reeds aan Sasria aangemeld moes gewees het.

Indien jy nog nie alle Sasria eise wat met die gebeurtenis verband hou, aangemeld het nie, maak ons 'n dringende beroep op jou om sodanige eise so spoedig moontlik aan ons te stuur, sodat ons, op ons beurt en as die Sasria Agent, die eise vir oorweging aan Sasria kan stuur.

Kontak ons gerus indien daar enige spesifieke eise is wat jy wil bespreek of indien jy enige ander navrae mag hê.
